AUDIT SUMMARY

Results in brief

In most areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Port management in a letter dated December 18, 2014, related to procurement. We appreciate the Port's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Port of Camas-Washougal from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Open public meeting minutes

- Payments/expenditures
- Procurement (bidding/prevailing wage)

Our opinion on the Port's financial statements is provided in a separate report, which includes the Port's financial statements.

INFORMATION ABOUT THE PORT

The Port of Camas-Washougal provides recreational and industrial facilities in Clark County. Specifically, the Port operates Grove Field, an airport and hangar facility located north of the city of Camas; a marina and launch ramp facility on the Columbia River adjacent to the cities of Camas and Washougal; and an industrial park located next to the Columbia River in Washougal.

An elected, three-member Board of Commissioners governs the District. The Board appoints an Executive Director to oversee the Port's day-to-day operations as well as its 15 employees. For fiscal year 2013, the Port had operating revenue of \$2.57 million.
