MINUTES OF THE REGULAR COMMISSION MEETING

PORT OF CAMAS-WASHOUGAL January 2, 2025

A Regular Meeting of the Commissioners of the Port of Camas-Washougal was held in person and virtually on Thursday, January 2, 2025, at 12 p.m.

PRESENT: Commissioner Larry Keister, Commissioner John Spencer, Chief Executive Officer Trang Lam, Director of Finance Krista Cagle, Director of Business & Real Estate Derek Jaeger, Director of Facilities Eric Plantenberg, Attorney Carolyn Lake, Administrative Assistant Mackenzey Thomason, and members of the press and public. The public has access through a designated Zoom conference call line or video link. Commissioner Marshall's absence was excused.

At 12:00 p.m. following the Pledge of Allegiance, Commissioner Spencer called to open the Regular Session public meeting to order. The meeting is being recorded and the chat function has been disabled.

PUBLIC COMMENT #1 (Items on the Agenda):

No comments.

CONSENT ITEMS

Minutes & Checks

Minutes from the SpecialMeeting on December 17, 2024, electronic payments and the issuance of general fund checks 9986-10005 and printed checks 50183-50184 in the total amount of \$613,443.62, Lease Termination Building 14 Bay 3 54-40 and the Strategic Plan Consultant Contract were presented for approval. After a brief discussion, a motion was made by Commissioner Keister and seconded by Commissioner Spencer, and the consent items were carried unanimously.

NEW BUSINESS/DISCUSSION ITEMS:

Resolution 1-25 Surplus of Property- Director of Finance Krista Cagle:

Cagle stated this is an annual housekeeping item. Cagle explained this allows the Port to sell and convey surplus nonreal property which would include vehicles and equipment. Cagle stated the Port is authorized to sell if the dollar amount for the item is less than \$22,830.00. Anything over that dollar amount would have to be publicly advertised. Approval will be requested during action items.

Resolution 2-25 Budget Schedule- Director of Finance Krista Cagle:

Cagle stated the resolution is to allow a change to the Port's budget dates for 2025. Cagle explained that October 15, 2025, will be the Adoption of the Preliminary Budget, November 6th & 13th will be the first and second publication of the preliminary budget adoption, and on November 19th a public hearing will take place, and the final budget will be adopted. Approval will be requested during action items.

Commissioner Spencer requested formal approval of Resolution 1-25 Surplus of Property presented during discussion items. Upon motion by Commissioner Keister seconded by Commissioner Spencer and carried unanimously, the approval of Resolution 1-25 Surplus of Property is effective January 2, 2025.

Resolution 2-25 Budget Schedule:

Commissioner Spencer requested formal approval of Resolution 2-25 Budget Schedule presented during discussion items. Upon motion by Commissioner Keister seconded by Commissioner Spencer and carried unanimously, the approval of Resolution 2-25 Budget Schedule is effective January 2, 2025.

CEO Trang Lam:

Lam wished everyone a happy 2025. Lam stated the Port will kick off its Strategic plan soon. Lam mentioned the Port's partner, RKm will hold an open house at the Port offices on January 15th from 4:30 pm-5:30 pm. Lam stated the purpose of the open house is so the public meet the development team and ask questions directly about the construction of the waterfront development.

Director of Business & Real Estate Derek Jaeger:

Jaeger wished everyone a happy new year. Jaeger stated that Pacific NW Waterways Association (PNWA) will hold a Green Corridor meeting on January 10th, which will be hosted at the Port of Camas-Washougal's admin building.

Director of Facilities Eric Plantenberg:

Plantenberg stated his team is completing annual inspections for all their assets. Plantenberg stated he is traveling to Florida to complete the final inspection for the houseboat from January 13-15th.

Director of Finance Krista Cagle:

Cagle stated training begins next week for the Port's new accounting software. Cagle stated the whole process has been quick and painless and she was looking forward to testing it out.

Commissioner Keister thanked Port staff for all their help in the past year.

Commissioner Spencer:

Spencer stated Lam told him that the levy inspection passed, and they had no serious corrections.




